This Privacy Policy explains how Big Thicket Association uses, and discloses personal information about our members, prospective members, and visitors to our websites at <u>www.bigthicket.org</u>, <u>www.nechesriveradventures.org</u>, and <u>www.thicketofdiversity.org</u>.

COLLECTION OF PERSONAL INFORMATION

Information collected directly from you: We may collect personal information directly from you, for example. Personal information we collect directly from you may include names and addresses, email addresses, and phone numbers.

Information collected from your device: Our website may use technologies such as cookies, web beacons, pixels, and other similar technologies to automatically collect certain information from your device. Our website may also use cookies and similar technologies to enhance your user experience and enable certain features such as keeping track of items you put in your shopping cart. Our email campaigns may also use tracking technologies such as web beacons, pixels and other similar technologies to automatically collect certain information such as your IP address, browser type and version, and email engagement statistics. We do not share personal information with third parties, as may be the norm with for-profit websites — as a non-profit organization, we operate as a rather closed system, focusing on
